Glossary

Bequest: This is a gift left to charity in your will. You can leave a set amount of money or a percentage of the residual in your estate.

RRSPs & RRIFs: Beyond a will, you can name a charity as the beneficiary of your RRSP or RRIF account(s). As such, upon death, Crohn's and Colitis Canada would receive the balance of the amount in your account.

Life Insurance: Similar to an RRSP or RRIF, you can name a charity as the beneficiary of your Life Insurance Plan. By choosing this option, Crohn's and Colitis Canada would receive the insurance proceeds upon your passing.

Stocks, Bonds & Mutual Funds: If you transfer ownership of your stocks, bonds or mutual funds to Crohn's and Colitis Canada before you sell them, you will receive a tax receipt for the fair market value of the stock, bond or mutual fund on the day of transfer.
