2023 CampGot2Go COVID-19 Waiver



To keep your camper safe, Crohn's and Colitis Canada is enforcing a COVID-19 vaccination policy and COVID-19 testing requirements at all of our 2023 Camp Got2Go programs this summer. Crohn's and Colitis Canada is closely monitoring public health guidelines and may have to cancel your child's acceptance or camp program as a result.

Proof of COVID-19 vaccination or a medical exemption is mandatory to apply to Camp Got2Go. All campers must have **3 doses of a COVID-19 mRNA vaccination**, meaning 2 doses of an mRNA vaccine and 1 booster dose **OR 2 doses (at least one of which should be of a bivalent series) AND proof of prior COVID-19 infection.** If your camper is exempt from the COVID-19 vaccine primary series or booster dose(s), you will be required to provide Crohn's and Colitis Canada with a medical exemption note, and your camper may be asked to complete additional COVID-19 testing before camp.

All participants (campers/volunteers/staff) must get tested for COVID-19 **24-48 hours before they arrive** at the campsite. Parents/Guardians will be responsible for ensuring their camper gets tested for COVID-19 before camp, and provide proof of a negative test no later than 24 hours before the camp arrival time. Campers will also be required to test for COVID-19 **upon arrival to camp** and **48 hours after arrival**. Crohn's and Colitis Canada will provide families with rapid antigen tests via mail 1-2 weeks before the start of camp, and we will provide on-site testing kits for all camp participants. Failure to comply with the testing requirements leading up to or during camp will result in the cancellation or dismissal of your child's camp acceptance.

If your camper shows signs or symptoms of COVID-19 while at camp, Crohn's and Colitis Canada will require them to quarantine in an isolation cabin on the campsite and test for COVID-19. If your camper tests positive for COVID-19, parents/guardians must be available to pick up their camper from the campsite or make any necessary travel arrangements. Please note that any additional costs incurred as a result of a camper testing positive for COVID-19 at camp will be the responsibility of the camper's parents/guardians. In the event of a camper testing positive for COVID-19 while at camp, Crohn's and Colitis Canada staff will work closely with parents/guardians to arrange their camper's departure from camp.
